ITS MEMBERS TO FURNISH GRADING AND ASSIGNMENTS
COMPLETED PRIOR TO THE STRIKE**

On stipulation of the parties, IT IS ORDERED THAT:

1. The following notice will be provided by Defendant GEO to members of the bargaining unit it represents:

GEO and the University have agreed that all employees in the GEO bargaining unit shall be advised to promptly provide to a person designated by their respective department chair any and all gradebooks or other documents showing grades for exams, papers, and assignments that students completed before the strike, or


ungraded exams, papers, or assignment turned in by students before the strike. These materials shall be provided in the normal format required prior to the strike, or in the format required by the instructor of record and/or Department Chair. Further, employees shall be advised to restore their Canvas gradebook to its state as of March 29, 2023 at 10:24 a.m.

2. The above notice will be provided to members of the bargaining unit via the Union's customary methods of communication, including electronic mail.

3. The University will grant access to Canvas to GSIs/GSSAs for the purpose of implementing this agreement.
